

## ANNOUNCEMENT No 002/2025 - DIN

The Paraná Sanitation Company – SANEPAR, through its Innovation and New Business Directory, in complement to Notice of Resumption No. 001/2025 – DIN, published on April 24, 2025, hereby announces the following corrections to the Public Call Notice No. 001/2025 – DIN, which pertains to the selection of a strategic partner for the formalization of a Technical Cooperation Agreement aimed at developing business opportunities related to the installation of optical fiber networks in sewage collector systems:
